"RESOLVED: The restatement of Bylaws of the CPNC be approved as submitted with the following changes:

1. Article V Paragraph 1 of the restatement be stricken and replaced with the following language:

"Section 1. Composition. The Board shall consist of fifteen (15) voting members and several non-voting advisors. Only CPNC stakeholders, as defined in Article IV above shall be selected or elected to hold a position on the Board. No single Stakeholder group shall comprise a majority of the Board, unless warranted by extenuating circumstances and approved by the Department of Neighborhood Empowerment ("Department").

The Board shall represent all the stakeholders in Canoga Park. The governing body must, to the extent possible, reflect the diversity of the neighborhood council's stakeholders. All stakeholders must be eligible to vote and run for at least one board seat. The election procedures created by Department or City Clerk pursuant to Section 20.36 shall require proof of stakeholder status for community interest stakeholders that must be consistent with and substantially equivalent to the evidential proof required of stakeholders who live, work, or own property. The Board shall be comprised of the following Members:

If a CPNC Board Member or officer moves away from or is no longer a Stakeholder in the Council area, their position should become vacant. "

2. Article V Paragraph 4 of the restatement shall be stricken and shall state the following:

"staggered terms. Appointed Members shall serve two (2) year terms. All terms will be staggered. In order to stagger terms, six (6) of inceptive Board members would serve two (2) year term and seven (7) would serve a four (4) year term. The seven (7) Board members who receive the highest votes will serve (4) year terms. The remaining six (6) will serve two (2) year terms.

- Report from Corinne Ho for Ad-Hoc committee for Board Retreat they discussed possible locations and agenda. Next meeting will be April 17 at community center.
- 10) Ron Clary reported on Land Use. The city has approved a 50,000 sq ft Amazon Distribution center where Vallarta used to be on Roscoe Blvd. Corinne expressed that Land Use planned to meet last month to discuss several issues but that there were scheduling challenges. Ed added that in the parking lot on the southwest corner of Remmet and Wyandotte (formerly the CDI parking lot) early talks say that they plan 5-story multi-unit (30 + apartments) which if happens, would change the face of the whole historic neighborhood. Property changed hands in October, but the community so far is kept in the dark about the project. Follow-up is needed to get accurate updates on the project and to have time to ensure the public is informed and can express their concerns or support.
