#### Discuss funding motions. The motions are:

- Reappointment of Michelle Miranda Fuentes to the Board for the Community Based Organizations Seat.
- b. Discussion and possible vote to approve that the Canoga Park Neighborhood Council (CPNC) participates in the 2022 Annual Homeless Count as a site coordinator sponsor/agency on Tuesday, January 25. Board Members Nauman Khan, Raymond Cole (Mary Paterson as an alternate) are designated as the site coordinators in partnership with the Los Angeles Homeless Services Authority (LASHA).
- c. Discussion and possible vote to approve \$5,000 for It's Overdue for Supplies and Outreach for their Cleanup events in Canoga Park. We are on a mission to make LA the cleanest city in the nation. We have been hosting daily cleanups mainly in Woodland Hills and Canoga Park for the last 390 days straight. We started in October 2020 and cleared 48,000 LBs of trash off the streets of LA with a grand total of 3500 participants. We have been awarded a certification of recognition by all 15 council members and the Mayor Eric Garcetti in March and October of 2021. We have created a leadership program in which anybody can sign up online and host cleanups using our platform. We would love to see more community engagement.

  Community School (NVCS) to offer a free music program to youth from low-income families who live in Canoga Park and nearby communities. Instruments will include piano, guitar, and drums. The program will run Nov 2021-Jun 2022 (Two 4-month sessions), be located at the Canoga Park Community Center, and have capacity for up to 36 participants per session. Grant funds will cover rent and partially cover teaching artists' compensation and administrative assistant compensation. The project's overall purpose is to advance artistic knowledge and equip youth with essential learning and life skills that will help them achieve academic success and live a happier and more fulfilled life.

#### Q4. Please describe the purpose and intent of the grant.

With the support of the Canoga Park Neighborhood council, Nueva Vision Community School (NVCS) will offer a free music program to youth from low-income families who live in Canoga Park and nearby communities. Instruments will include piano, guitar, and drums. The program will run Nov 2021-Jun 2022 (Two 4-month sessions), be located at the Canoga Park Community Center, and have capacity for up to 36 participants per session. Grant funds will cover rent and partially cover teaching artists' compensation and administrative assistant compensation. The project's overall purpose is to advance artistic knowledge and equip youth with essential learning and life skills that will help them achieve academic success and live a happier and more fulfilled life. These youth development outcomes include the ability to problem-solve, personal fulfillment, and the ability to express oneself.

Our program will not only offer music instruction but will also offer free performances by our teachers and students. We believe now more than ever, the youth from these communities need the positive effects of music and arts education. Our curriculum emphasizes that each student shares their art with their family and community (e.g., end-of-term performances, etc.). Therefore, our free music program will enrich the lives of the participants and enrich the lives of those around them. We genuinely believe the arts bring hope and healing, and we are optimistic that through music, we can make a positive impact in Canoga Park and the surrounding communities.

NVCS has served the San Fernando Valley community for close to 15 years.
