When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial \*9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of the Board.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting; only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned. Any messaging or virtual background is in the control of the individual board member in their personal capacity and does not reflect any formal position of the Neighborhood Council or the City of Los Angeles. The Neighborhood Council system enables meaningful civic participation for all Angelenos and serves as a voice for improving government responsiveness to local communities and their needs. We are an advisory body to the City of Los Angeles, comprised of stakeholder volunteers who are devoted to the mission of improving our communities.

## MINUTES CANOGA PARK LAND USE COMMITTEE AUGUST 16, 2022

The Canoga Park Neighborhood Council Land Use Committee convened for the August meeting via zoom on August 16, 2022 at 6:30 P.M.

Members present: Brian Mallasch; Corrine Ho, Steve Slutzah, Mark Vetter, Jack Dawson.

Members absent: John Parker

There was a delay getting certain members to a camera.

Chairman Brian Mallasch began the meeting with greetings and roll call.

- 1. Upon mutual agreement, the order of the agenda was changed and the Committee heard the presentation of Owner Representative Robert J. Amond concerning the matter of a potential conditional use permit application pertaining to use of property located at 21252 Nordhoff. (Transition from current designated use as salvage yard to storage facility.) No vote or action was taken.
- 2. There was then a discussion regarding the resignation of Brian Mallasch as Chair and selection of a new Chair for the Committee including nominations and election of a new Chairman for the Committee. After discussion, Mark Vetter moved and Corrine Ho Seconded a motion that Ronald Clary be appointed as Interim Land Use Chair for a period not to exceed ninety days as Committee Chair, subject to approval by the Council as a whole. The motion was approved unanimously.
- 3. GENERAL PUBLIC COMMENT, ADJOURNMENT. After a period of general public comment, the meeting was adjourned.
