Meeting convened at 6:35 P.M.

I. Welcome by Committee Chairman.

1. II. Presentation of Local Office Representatives: Elizabeth Ene, Planning of Bob Blomenfield, District 3 office presented.

Ms. Ene reported on the following:

ED1: There had been several applications for 100% affordable housing project(s) under the ED1 Fast Track program on ("R1") zoned property. The Council member and Mayor intervened to prevent further approval in such areas. ED1 Projects within CD3 in R1 are denied. Projects can develop through conventional permit processes.

Billboards: City has passed approval of LED Billboards. No new Billboards are pending in CD3. Billboards are currently planned in Universal City and Downtown areas.

RAMS: Confirmed RAMS will begin development within Canoga Park - Woodland Hills district.

Community Plan for Canoga Park, West Hills, Woodland Hills: To be discussed at the next meeting.

- V. Discussion of the possible future composition of the committee in light of anticipated bylaw changes. The Chair introduced the topic of how possible pending bylaw changes would potentially affect the composition of the Committee.
- VI. Assignment of responsibility concerning review of new applications. The Chair mentioned several pending applications and individuals volunteered to review them and report on them at the next meeting.

VII. Pending Issues

It was discussed that the Current Case No: ZA-2023-4034-PAD ("Raising Cane's" commonly known address, 6501 Topanga Canyon Boulevard, Canoga Park, CA 91303 would be discussed at the next meeting.

Jack Dawson addressed concerns of illegal use of property selling cannabis. The Chair identified concern should be raised as a future Agenda item including consideration to get community groups involved that may hold interest, such as our local police department.
