i. City Council has discussed making homeowners responsible for the cost of sidewalks repairs.

A California State law in 1911 placed the responsibility of repairing damaged sidewalks with the property owner, because the sidewalk and the parkway are actually within the property owner's boundaries. The City has an easement to make a sidewalk that the public can use. Legally, the property owner is responsible for repairing the sidewalk. We must maintain focus on the core City services that are paid for out of the General Fund, such as public safety, parks, libraries and streets.

PLUM approved the recycling center with conditions that were discussed in the Land Use Committee. The following conditions will apply:

- Recycling bins will be screened with landscape
- Shopping cards will be maintained inside an enclosed area, which will also be screened with landscape.

-Roscoe entrance/exit to shopping center will only be used an entrance and not an exit.
