II. General Public Comment on Non-Agenda Items:

- 1. Yolanda Aldaz from DC Collective, a legal marijuana collective, spoke on the benefits of marijuana and the commitment to be good corporate citizens.
- 2. Rene Carrion from the West Hills/Canoga Park Chamber of Commerce indicated an intent to request funding for the 2017 Memorial Day Parade.
- 3. Matt Pavoko and Kyoto Hibino from Save Porter Ranch spoke on the need to permanently close the Aliso Canyon natural gas storage facility.
- 4. Don Evans spoke on the lack of authority of the neighborhood councils. He feels that neighborhood councils should be as city councils, with authority over city agencies in the community.

III. Presentation by Los Angeles City Council President Herb Wesson

- The LA City Council is looking for ways to reduce crime. LAPD is recognized as one of the most progressive urban police agencies in the nation.
- Mr. Wesson is the chair of the committee that oversees neighborhood councils, and believes that neighborhood councils make a difference. For FY 2016-17, an additional allotment of \$5000 for each neighborhood council was approved, and funds will be made available to neighborhood councils soon. It is his goal to make the \$5000 increase permanent, rather than year-to-year, and to restore neighborhood council budgets to the original \$50,000. He also spoke about allowing for carry-over in neighborhood council budgets, to prevent the hurried spending at the end of the fiscal year. Finally, as a council member, he uses the neighborhood councils in his council district to vet community projects.
- Question and Answer with Canoga Park Neighborhood Council Board and Public
 - When asked about the Aliso Canyon natural gas storage facility, Mr. Wesson indicated that safety is the 1st priority and that he will educate himself on the issue before voting.
 - When asked about homelessness, Mr. Wesson stated that Los Angeles is the first city on the country to have a standing committee on homelessness. As of the meeting, the city of Los Angeles has budgeted \$138 M for services for the homeless, including housing and wrap around services; and that the city is pursuing unprecedented interagency and intergovernmental cooperation in attempting to meet the needs of the homeless. He also referred to Measure HHH, a bond measure to raise \$1.3 B to meet the needs of the homeless. If the measure passes, Mr. Wesson indicated that he would advocate for funds for Canoga Park. It was suggested that the city look at the San Fernando Valley Rescue Mission as a model for services.

IV. Community/Government Reports & Announcements

1. LAPD Captain Vernon of the Topanga Division – Reported that a recent Gallup Poll found that 76% of respondents approve of the job that local law enforcement is doing, forming a 'silent majority' compared to activists who speak out against police violence. He sees public engagement as an important factor in the positive perception. He reports that Canoga Park is 'relatively safe' compared to other areas of the San Fernando Valley and Los Angeles. There is an increase in property crimes, specifically the theft of items from vehicles. He indicated that many of the thefts are NOT break ins, as many vehicles are left unlocked for various reasons.

Rhonda Spires At-Large Rep. Captain Vernon spoke about the decline in murders in Los Angeles from over 1100 in 1992 to 280 in 2015. He attributed the decline to mandatory sentencing laws (such as "3 strikes") kept many potential criminals off the streets. Captain Vernon also sees a connection between homelessness and mental illness, especially drug induced mental illness.

Jenny Portillo, Canoga Park Field Deputy for LA City Councilmember District 3 Bob Blumenfield There is a need to educate people who live in apartments about multiple-use bins and bulk item pick-up. Ms. Portillo also indicated that Mr. Blumenfield's holiday party is scheduled for December 8 at 5:00 pm at his field office.

Rhonda Spires At-Large Rep. PROCESS FOR RECONSIDERATION in accordance with Article VIII Meetings, Section 4 of the current CPNC By-Laws:

"The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place immediately following the original action or at the next regular Neighborhood Council meeting. The Board, on either of these two (2) days, shall: (1) make a Motion to Reconsider and, if approved, (2) hear the matter and take an action. If the Motion to Reconsider an action is to be scheduled at the next meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) a Motion to Reconsider the described matter and (2) a [Proposed] Action, should the Motion to Reconsider be approved. A motion for reconsideration can only be made by a Representative who has previously voted on the prevailing side of the original action taken. If a motion for reconsideration is not made on the date the action was taken, then a Representative on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Brown Act."

PROCESS FOR FILING A GRIEVANCE in accordance with Article XI Grievance process of the current CPNC By-Laws:

- "A. Process. Any person or group adversely affected by the decisions or policy of the CPNC may file a written grievance with the Board. Within ten (10) working days, the Board shall then refer the matter to the grievance committee, who shall have ten (10) working days to meet with the person submitting the grievance and to discuss ways in which the matter may be resolved. The committee shall prepare a written report for the Board outlining their recommendations for resolving the grievance. The Board must then address the report at the next regular or special meeting.
- "B. Appeal. In the event that a grievance cannot be resolved through this grievance process, the matter may be referred to the Department for consideration or dispute resolution in accordance with the Plan.
- "C. Matters which can be grieved. The formal grievance process is not intended to apply to Stakeholders who simply disagree with a position or action taken by the Board at one of its meetings. Those grievances can be discussed at Board meetings. This grievance process is intended to address matters involving procedural disputes, e.g. the Board's failure to follow these bylaws or its Standing Rules."

BROWN ACT REVISION AND LANGUAGE IN THE BYLAWS

The City Attorney wishes to bring to your attention a recent amendment to the Brown Act* that takes effect on July 1, 2008, and impacts the wording of board agendas and also impacts how the records, which are reviewed by board members in anticipation of a meeting, are to be made available to the public. This information is intended to provide you with guidance in preparing the agendas for the Neighborhood Councils.

The pertinent amendment is contained in Government Code section 54957.5 paragraph (b) reads as follows:

- "(b) (1) If a writing that is a public record under subdivision (a), and that relates to an agenda item for an open session of a regular meeting of the legislative body of a local agency, is distributed less than 72 hours prior to that meeting, the writing shall be made available for public inspection pursuant to paragraph (2) at the time the writing is distributed to all, or a majority of all, of the members of the body.
- (2)A local agency shall make any writing described in paragraph (1) available for public inspection at a public office or location that the agency shall designate for this purpose. Each local agency shall list the address of this office or location on the agendas for all meetings of the legislative body of that agency. The local agency also may post the writing on the local agency's Internet Web site in a position and manner that makes it clear that the writing relates to an agenda item for an upcoming meeting.

(3) This subdivision shall become operative on July 1, 2008."

Typically, board members receive an agenda and written materials to review in advance of a meeting (the "agenda packet"). Government Code section 54957.5 clarifies that once the writings or agenda packet are delivered to a majority of the members on the board, the records, unless specifically protected from disclosure by the Public Records Act, must be made immediately available upon request. If written materials are submitted to the board after the posting of the agenda, then the agency shall designate a location (and an optional website link) where the public may view the records. Therefore, Neighborhood Councils should provide for easy access to the records by making them available on the website in addition to a physical location. It will be important to insure that upon distribution of the agenda packet to a majority or all of the board members, the documents are promptly placed in the correct location and posted on the website."
