  - 19 bills introduced this session, on topics such as homelessness and higher education

d. Motion and possible action to remove Terrance Jakubowski as a CPNC board member and declare At-Large seat vacant.

Moved by Don Evans and seconded by Ron Clary. Discussion: Terrance is no longer able to attend meetings at their current time. The city attorney has been consulted on this matter.

Roll call vote (2/3 majority required): 10 Yes. 3 No. 0 Abstain. Motion passed.

- Motion to approve up to \$10,000 for Election 2019 outreach and events. *Moved by Mary Paterson and seconded by Quincy Clemons.* Motion made to amend the item to specify that the funding of \$10,000 should be moved from the NPG category and placed into the Election Outreach budget. However, there is not \$10,000 in the NPG category at this time, so the amount needs to be changed. As it stands, >\$4000 in the Outreach can be used for the election without the need for any further change or vote. Motion retracted.
- f. Motion to reimburse Kendra Kimball in the amount of \$160.42 for CPNC election material printing costs. Moved by Mary Paterson and seconded by Thema Bryant-Davis. Discussion: Materials printed for the Rally in the Valley event and to be displayed at general board meeting. Roll call vote: 13 Yes. 0 No. 0 Abstain. Motion passed.
- g. Motion to approve up to \$250 for Valley Alliance of Neighborhood Councils' 2019 Annual Mixer. This mixer is a great way for NCs to network and celebrate the great work NCs are doing in the San Fernando Valley. *Moved by Bobbi Trantafello and seconded by Quincy Clemons.*Public comment by Gary Fordyce: The VANC mixer is a great event, elected community officials attend. CPNC banners can be displayed. *Roll call vote: 12 Yes. 1 No. 0 Abstain. Motion passed.*
- Motion to approve up to \$5000 for sponsorship for the annual Memorial Day Parade.
  Board members Brian Mallasch and Bobbi Trantafello recused themselves; as a result, quorum was lost.

PRESENTATION/DISCUSSION/POSSIBLE VOTE concerning the recommendation that a Community Impact Statement be issued by the Canoga Park Neighborhood Council in support /opposition of the resolution introduced the Los Angeles City Council by Councilmember Bob Blumenfield concerning the Warner Center Plan (File Number 13-0197) suggesting that the Planning Department and Housing and Community Investment Department, in consultation with the City Attorney, report on the feasibility and options for including affordability requirements, including moderate and workforce housing, within the Warner Center 2035 Plan; and how to integrate and balance these new incentives and requirements with the recently adopted Affordable Housing Linkage Fee Ordinance (File Number 17-0274), and to instruct the Planning Department to complete a comprehensive review of the development incentives within the Warner Center 2035 Plan to identify opportunities to create strong incentives for affordable housing at all income levels. Council File Number 13-0197-S9.

Moved by Ron Clary and seconded by Carey Martinez.

Discussion: Goal is to encourage affordable housing development. Affordable housing subcommittee of the PLUM supports this CIS.
