I. CALL TO ORDER & ROLL CALL:

- Alberto Vargas gives a report from Assembly Member Gabriel's office.
 The Assemblymember Gabriel internship will return to a remote setting and the office is working with different Cedar Sinai hospitals to create community resources.
- Tessa Charnofsky gives the report on the new mask mandate, noting that those who are fully vaccinated have the option of not masking indoors.
- Duke Dao and SLO Moreno give the crime rate numbers in the city, specifically noting the specific car models that were being stolen the most.
- Tim Glick reports from Council Member Blumenfield's office. They firstly thanked everyone for their participation in the homeless count. In addition, the council approved meal deliveries to seniors, serving over a million meals.
- Raule and Vanessa from the Department of Neighborhood
 Empowerment: Vanessa introduces Raul to the boarding, noting his
 intense training and his assignment to Canoga Park. Raul gives his
 greetings to the board and extends his assistance to anyone who needs
 help from the Neighborhood Council System.
- Jessica Gonzalez gives the Budget Advocate report, noting that she went over it and saying that there is a specific link for neighborhood councils to visit to track council files from the city. She will forward the report to everyone in case they would like to read it.
